Chairman Werner called the meeting to order at 6:00 P.M. Present were Commissioners Terry Werner, Todd Tondee, and Lynn Humphreys; Road Supervisor Kelly Brownsberger, District Clerk Shirley Walson; Administrative Assistant Korrei Kruger, and District Engineer Laura Winter. Guests were Rocky Banks, Daniel Baker, Dave Miller, Mark Fisher, and Glenn. Chairman Werner led in the Pledge of Allegiance.

CONFLICTS OR CHANGES

No conflicts were stated. No changes to the agenda were requested.

APPROVAL OF AGENDA

CURRENT BUSINESS

LGIP Fund Inactivation, Huetter Overlay

All funds have been expended from this account for the Huetter overlay so it can be closed. Commissioner Tondee **moved** to authorize the Chairman's signature on the inactivation on the Huetter Overlay account. Commissioner Humphreys seconded. **Motion carried** unanimously. [4/3/19 Brd Mtg]

East Wellesley Road Vacation and Abandonment, Set Public Hearing

An adjoining property owner is asking to vacate and abandon the District's closed portion of East Wellesley Avenue. A public hearing needs to be set for the abandonment with a suggested date of May 15, 2019. Spokane County, the City of Stateline Village, and the City of Post Falls are all included in the notifications. Commissioner Humphreys **moved** to set a public hearing for the East Wellesley Road Vacation and Abandonment on May 15, 2019 at 6:00 pm. Commissioner Tondee seconded. **Motion carried** unanimously. Resolution 2019-03 Federally Funded Policy and Procedure

District Clerk Shirley Walson reminded the Board of a discussion had prior to audit season of a requirement for all entities who receive federal funds are to have a written policy which include such items as allowable costs, procurement procedures, advance payments and reimbursements. Ms. Walson stated attorney Susan Weeks agreed to do one for the four highway districts but because East Side had theirs completed, it would be forwarded for our template. The Board had concerns that the attorney had not reviewed it. Commissioner Humphreys **moved** to table this item until such time legal staff has reviewed it and provided comments. Commissioner Tondee seconded. **Motion carried** unanimously. [4/3/19 Brd Mtg]

Weed Spray Agreement

An agreement between the District and Panhandle Spray Service for the period of April 1, 2019 to

December 31, 2019 was presented. Cost is \$30/acres for spraying by spray truck and cost of chemical and \$90/hour for spot spraying by spray truck and cost of chemical. Commissioner Humphreys asked they will determine the acreage with Mr. Brownsberger stating that we provide them with road miles, then they set five feet from the edge; bare ground is two feet from the edge. Commissioner Humphreys **moved** to enter into a one year agreement with Panhandle Weed Spraying for weed spray control on our right-of-way and any other areas as determined by the road supervisor. Commissioner Tondee seconded. **Motion carried** unanimously. [4/3/19 Brd Mtg]

ROAD SUPERVISOR

Seltice Way Transit Bus Shelter Update – A comparison of costs was reviewed for a bus shelter/transit stop on both the east side and west side of Huetter. Hoping the costs would be nearly one-half if built on the west side, they came out nearly the same. After much discussion once again, the Road Supervisor will get quotes for curb costs and Commissioner Tondee wants Kootenai County Transit's opinion if the west side can be a stop as soon as possible to assist in decision making. [4/3/19 Brd Mtq]

Spokane Street Bridge Funding – Mr. Brownsberger spoke with Dan Coonce of LHTAC regarding the funding and the wax tape application at a cost of \$2.4 million has been secured. Out of that amount, \$1.8 will go towards construction so there will be a shortfall of \$300K but construction isn't until 2022 so the District may be able to be funded throughout the time. The Board felt it was a good investment to protect what we have invested. [4/3/19 Brd Mtg]

Cliffhouse Road – Pictures of flooding were shown. Mr. Brownsberger has asked RYA to engineer a replacement project. In the meantime, Hauser has asked for a culvert replacement on Woodland Beach Road and they will pay costs so these projects will be done concurrently. Questions were answered regarding the amount of drainage, location of culverts, and swales. [4/3/19 Brd Mtg]

Prairie Ave – RYA will design an overlay from Chase to McGuire. Originally budgeted was a CRABS on Prairie from SH41 to Greensferry but due to the work on SH41 and annexation by the City, Mr. Brownsberger moved the project out to this location. It will complete the all-weather build of Prairie. The design should be complete so it can be bid in early May. [4/3/19 Brd Mtg]

Minor Subdivision Responses – Mr. Brownsberger let Joe Dobson know the District would not sign off on the subdivision that was discussed at the last meeting. He also spoke with attorney Susan Weeks asking if she would draft a letter for the District to the Board of County Commissioners. Ms. Weeks said she will have that for the April 17 meeting. [4/3/19 Brd Mtg]

Riverview Drive (Skalan Creek) Bid Opening – April 2 bids were opened with Norwest Grading was apparent low bid \$531,177, under the engineer's estimate. La Riviera was the only other bidder at \$753,528; the engineer's estimate was \$687,156. [4/3/19 Brd Mtg]

Wash Basin Enclosure – ML Architect provided a quote of \$1,620 to design the enclosure with Mr. Brownsberger authorizing him to proceed. [4/3/19 Brd Mtq]

Prairie and Greensferry Appraisals – These have been completed and will be provided to the Board as soon as he receives them. [4/3/19 Brd Mtg]

Riverview Guardrail Project – ITD was going to provide the independent review; finding they are too busy, it will be done by an independent reviewer. Mr. Brownsberger will receive a quote soon. [4/3/19 Brd Mtg]

Crew Update – Sweeping is going on with sand being hauled off, sidewalks are also being done. Road restrictions are beginning to lift on the prairie. [4/3/19 Brd Mtg]

Prairie Overlay – Surveying begins the following day. [4/3/19 Brd Mtg]

Beck Road – Preliminary submittal will be provided to the District and LHTAC the following day. [4/3/19 Brd Mtg]

Pleasant View & Prairie Utility Agreement

Angela Comstock of JUB Engineers presented the *Lump Sum Utility Agreement* for this project. Ms. Comstock stated it was a standard agreement for Avista to relocate existing facilities; it explains standard pass-through costs currently anticipated at \$23,144.56. Commissioner Tondee moved to approve the lump sum utility agreement, with no number assigned, and to authorize the Chairman's signature. Chairman Werner seconded. **Motion carried** by majority vote. T2 Awards

Laila Kral was present to awards for earned 80/160 hours classroom time. Leslie Likes and Terry Werner have earned Road Scholar and Terry Werner, Kelly Brownsberger and Randy Neal have earned their masters award. Ms. Kral explained this training includes safety, professional development and a large amount of improving roadway noting Chairman Werner was the first commissioner to earn this award. Riverview Drive Utility Hearing

Chairman Werner read the rules of the hearing and opened the hearing to the public. With no one present who wished to speak; neither the road supervisor nor the consultant had comments and Chairman Werner closed the public hearing and opened it to Board discussion. Commissioner Tondee stated since there were no comments, he **moved** to require the utility companies accommodate the project and relocate the utility facilities as required for the Riverview Drive Guardrail Installation project, Key Number 19749. Chairman Werner seconded. **Motion carried** by majority vote. [4/17/19 Brd Mta]

Minor Subdivision Responses

Road Supervisor Brownsberger reported he was not ready and asked to table it until the May 1 agenda. Chairman Werner confirmed tabling this item. [4/17/19 Brd Mtg]

Spokane Street Bridge Cost Estimates

Mr. Brownsberger provided a summary of cost options. The Board's discussion focused on the \$2.48 million dollar option which was the recommended option. Commissioner Tondee asked for confirmation that the District received verbal affirmation from LHTAC is committed for the additional cost. Mr. Brownsberger agreed stating the District will still have approximately a \$300K shortage, however the project is projected for 2022 and LHTAC hopes to obtain that funding as well. Commissioner Tondee **moved** to choose Option 8 which includes the tape and for the engineer to move forward with design of that option. Chairman Werner seconded. **Motion carried** by majority vote. [4/17/19 Brd Mtg]

Kootenai Electric Director Election

Each board member knew the incumbents and one other candidate and felt either would do well. Commissioner Tondee **moved** to vote in favor of keeping the incumbents.

Seltice Way Pay Request

Mr. Brownsberger explained the City of Coeur d'Alene is working towards closing this project, primarily landscaping is still needed. Commissioner Tondee asked if it would be advantageous to keep the project opened until such time the transit stop is settled. Chairman Werner added as this is not the final invoice, we would still have some time. Commissioner Tondee **moved** to authorize payment in the amount of \$926.25 on Invoice 13, Pay Request 15 for the Seltice Way Revitalization Project. Chairman Werner seconded. **Motion carried** by majority vote. [4/17/19 Brd Mtg]

Resolution 2019-03, Federally Funded Procedures

District Clerk Shirley Walson stated attorney Susan Weeks has reviewed the document stating she had no problems with the verbiage. Ms. Walson stated CPA Mary Richter had reviewed it for East Side Highway District so it has been approved by both an auditor and legal staff. Commissioner Tondee **moved** to approve Resolution 2019-03 Federally-Funded Policy and Procedure to protect our federal funding and that all commissioners will sign. Chairman Werner seconded. **Motion carried** by majority vote. [4/17/19 Brd Mtg]

LEGAL

Proposed Flood Ordinance - Attorney Susan Weeks stated Pat Braden and David Callahan informed her it would be brought forward Omnibus III hearing in May or June. They didn't expect the hearing to be as contentious as expected so it should be done soon. [4/17/19 Brd Mtg]

ROAD SUPERVISOR

Transit Stop – Mr. Brownsberger met with the Kootenai County Transit Department last week. They did not think relocating the bus stop to the west side of Huetter would be a bad idea however they would need to have a 30-day public comment period and will begin that process. They added they could obtain grant funding which could be a timely matter. Mr. Brownsberger is still looking into contractors. He added he can ask the City to keep the project open but the Board felt that may not be necessary. [4/17/19 Brd Mtg]

Subdivision Reviews – The quarterly report was provided to the Board regarding minor requests that comments had been done by staff. Chairman Werner asked if we knew yet if Beck Industrial Park was going to be public or private; Mr. Brownsberger told Bill Krick of Northwest Grading at the Beck Road Open House that he's really past the point the District would be able to accept the roadway. [4/17/19 Brd Mtg]

W. Riverview (Skalan Creek) Selection Committee – Ruen Yeager has been selected to do the Construction, Engineering, and Inspection (CE&I) for the Skalan Creek project. Regarding the contractor award, Northwest Grading did not submit all required documentation with the bid and has now appealed their status. Construction cannot begin until August 1 due to bird migration, so hopefully the award will be ready at that time. [4/17/19 Brd Mtg]

Prairie, McGuire to Chase Overlay with an alternate from McGuire to Corbin – Mr. Brownsberger authorized Darius Ruen to get a bid package out with the opening scheduled for the May 15 Board Meeting. [4/17/19 Brd Mtg]

Riverview Guardrail – LHTAC has notified the District the review of the appraisals has been approved so Ron Harvey of RAH Consulting was notified to proceed and has sent letters to the property owners. [4/17/19 Brd Mtg]

Prairie and Greensferry Intersection – Three of the four property owners have responded to Mr. Harvey with Mr. Brownsberger authorizing an increase in one offer. [4/17/19 Brd Mtg]

Waterline Project – A waterline installation is beginning on Riverview from South Greensferry to Snowshoe supplying water to the new Riverview Heights subdivision. Also, South Greensferry Water System is looking to construct a large upgrade to their system in the same area working in and around Rainbow, Kelly, etc. with quite a few crossings. [4/17/19 Brd Mtg]

Crew and Staff – Weight restrictions have been opened up quite a lot; all should be opened by the end of the month with the exception of few bad spots and the most northern roads. Wednesday, April 24, First Aid and CPR will be provided to all employees and the board members were invited. Also April 24 is Administrative Assistant's Day and with a lunch date of April 30 set for office staff and the Board. [4/17/19 Brd Mtg]
