Regular Meeting – December 4, 2019, 6:00 pm, E. 5629 Seltice Way

Chairman Tondee called the meeting to order at 6:00 P.M. Present were Commissioners Todd Tondee and Terry Werner; Road Supervisor Kelly Brownsberger, District Clerk Shirley Walson; Administrative Assistant Korrei Kruger, and Ruen Yeager Engineer Laura Winter. Commissioner Humphreys was present via telecommunication as allowed by Idaho Code 67-2342(5). Assistant Road Supervisor Dave Yerian was also present. Chairman Tondee led in the Pledge of Allegiance.

CONFLICTS OR CHANGES

No conflicts were declared; no changes to the agenda were requested.

APPROVAL OF AGENDA

Commissioner Werner **moved** to approve the agenda as presented. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/4/2019 Brd Mtg]

Policy Manual Quote, Skye Mercer

Ms. Mercer was not available for the meeting. Commissioner Werner **moved** to table this item until the December 18, 2019 Board Meeting. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/4/2019 Brd Mtg]

Bayshore Estates, TIA Response

A response was received from Ben Goodmansen, EIT, Whipple Consulting Engineers in regards to the District's comments for the Bayshore Estates Traffic Impact Analysis. Ruen Yeager & Associates provided a response to the Board regarding Mr. Goodmansen's letter. Road Supervisor Kelly Brownsberger asked the Board if they approved to send RYA's letter along with the District's cover letter to Kootenai County. Commissioner Werner **moved** to forward the Bayshore Estates response letter to Kootenai County. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/4/2019 Brd Mtg]

Lost Creek Phase 3, Bond Reduction and Road Acceptance of Walden Loop & Wicklow Court Waldos have asked to release their bond that has been held in the amount of \$225,000. They were asked to submit a replacement bond in the amount of \$10,000 due to drainage improvements and the road gets through the winter. At this time Commissioner Werner **moved** to accept Walden Loop and Wicklow Court into the District's road system and to also authorize the Chairman to sign the bond reduction lowering the bond to \$10,000. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/4/2019 Brd Mtg]

Prairie, Meyer to SH41, Grant Funding

Mr. Brownsberger reminded the Board there may be possible funding available for Prairie Avenue from Meyer to SH41. KMPO released a call-for-projects on the urban systems qualifying this location of Prairie Avenue. He spoke with City of Post Falls Rob Palus who is very interested in partnering with the District to complete this portion; an agreement will be required for their match

on the portion of the City's work. Commissioner Humphreys asked if it will include funds to purchase the railroad right-of-way with Mr. Brownsberger answering the railroad should go away with the SH41 project and the Board had already authorized the Road Supervisor to spend up to \$175,000 for that acquisition. Commissioner Werner added there was a lot of projects competing. Commissioner Werner **moved** to forward the grant funding app for Prairie from Meyer to SH41 to KMPO. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/4/2019 Brd Mtg]

Riverview Guardrail State Local Agreement

This agreement is for construction for the guardrail project and added an authorized representative must be named. With the retirement of the Road Supervisor, Commissioner Werner requested to authorize the "Director" rather than a name due to the retirement of Mr. Brownsberger. Commissioner Werner **moved** to put the responsible party in charge as the Director and authorize the Chairman and Board to sign the agreement of Project Number A019(749), Riverview Drive Guardrail Installation. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/4/2019 Brd Mtg]

CORRESPONDENCE

Hidden Hills 2nd Addition Comment – The District is responding to Kootenai County regarding a minor subdivision off of Advent Lane. Where they access is a non-maintained section of right-of-way and a \$3,500 in-lieu-of fee is required.

Thank you card – A note stating the crew did a tremendous job and has been the best money spent.

ROAD SUPERVISOR

Plow Purchase – Road Supervisor Kelly Brownsberger is requesting purchase of a snow plow for the loader, replacing a 25-year old plow. The cost is \$19,667.07, includes quick coupler, and was included in the budget however it will take approximately six months to be built. Commissioner Werner **moved** to approve the purchase of a loader snow plow from Western State in the amount \$19,667.07. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/4/2019 Brd Mtg]

Pleasant View and SH53 – Mr. Brownsberger had a visual available show the proposed right-of-way for the proposed overpass and removes a large portion of the District's parcel. He spoke with the surveyor questioning the design asking if it can be reduced. Also discussed was the right-of-way along Hauser Lake Road and Hollister, etc. Basically, if we are maintaining the road at this time, we will inherit the right-of-way once this project is complete, however the Board feels the structures should be under the jurisdiction of the State. [12/4/2019 Brd Mtg]

Pleasant View and Grange – Mr. Brownsberger informed the Board of rumors of a major trucking business coming in directly south of the transfer station. The developer has been in contact with Glenn Miles at KMPO as well as the City of Post Falls. Mr. Brownsberger told Glenn and the City the District will ask for commercial industrial standards resulting in thicker pavement, however we would not ask for curbs and sidewalks. He added the Board may want to ask for 6-inches of pavement rather than the standard 4-inces in the event in they propose 129 lb. trucks; Pleasant View was built with 6-inches. [12/4/2019 Brd Mtg]

Prairie and Pleasant View Intersection - On September 18, 2019, the Board approved a motion to sign the BPA agreement for the Prairie and Pleasant View Intersection project when it was received with the District's required changes. Mr. Brownsberger informed the Board that agreement was received December 4, 2019 and Chairman Tondee signed it prior to the meeting. He added right-of-way acquisitions have been moving slowly through the title company but the Clerk has been proding them in order for them to be completed. [12/4/2019 Brd Mtg]

Huetter and Lancaster Intersection – The District owns one-half of this intersection and Lakes Highway District has the other half. LHTAC grants applications for safety improvements are coming up and due to fatalities and property damage, both districts are talking about doing a joint application for a roundabout. Director Eric Shanley from LHD began the application and sent it to Mr. Brownsberger for input; he believes it will be on the next agenda for Board approval. Commissioner Werner asked about the possibility of Rathdrum annexing into this location with Mr. Brownsberger stating they are one-half mile west and does not believe that will happen soon. [12/4/2019 Brd Mtg]

Prairie and Idaho Intersection Project – Mr. Brownsberger met with a developer in regards to the northwest corner of the intersection. The project proposed to purchase the parcel to gain the small triangle on the south side of the railroad tracks however it includes the parcel north of the railroad which would be an uneconomic remainder. The remainder is proposed to have storage units built on it as well as be annexed into the City of Post Falls. [12/4/2019 Brd Mtg]

Skalan Creek Project – Ruen Yeager and Associates will ask for a supplemental to their agreement for inspection on this project. As the project ran in to a lot of problems with the culvert failure, there will be additional funds needed. There is some funding left in the project but at this time we're not sure if those funds will be enough to cover the needed upcoming funds. [12/4/2019 Brd Mtg]

Crew update – Some deicing has taken place but no snow plowing. Brush cleaning is being done as well as some drainage issues. [12/4/2019 Brd Mtg]

ENGINEER

Prairie and Greensferry Partial Pay Estimate – Engineer Laura Winter reports this item is not yet ready with RYA receiving information just prior to the meeting and it could not be verified in time. Commissioner Werner **moved** to table the Prairie-Greensferry Partial Pay Estimate to the December 18 meeting. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/4/2019 Brd Mtg]

Rail/Highway Stop Sign Study – With new legislation requiring an engineered study in the event jurisdictions wish to keep stop signs at passive railroad crossings, Laura Winter stated RYA has almost completed their work. Grange, Idaho, Corbin, and Huetter currently have stop signs and warrants show they should stay. 12/4/2019 Brd Mtg]

OFFICE

Blue Shield Discount Program – District Clerk Shirley Walson informed the Board the discount program will not take place again this year as she could not obtain anyone to do blood draws at the District. [12/4/2019 Brd Mtg]

Access Management Ordinance – Notice of the ordinance was published in the Coeur d'Alene Press on November 12, 2019 and therefore is in effect as of that date. [12/4/2019 Brd Mtg]

Director Intro Materials – Ms. Walson asked the Board what they may want to have available for the new Director's employment. Use of the District vehicle was discussed as well as implementing a credit card policy. Ms. Walson will have one for review at the next meeting.

Year End Bonus – Ms. Walson reminded the Board of the year end bonus policy and that it states the Board will decide on the amount. CURRENT BUSINESS

Policy Manual Quote, Skye Mercer

The Board asked Ms. Mercer for a quote to work with the District for the possibility of converting to a Paid Time Off (PTO) plan rather than sick and vacation time provided. Ms. Mercer presented a three-tiered quote depending on how far the Board wants to go with a review; pros and cons of PTO; and how she will proceed with the plan. Chairman Tondee stated he is not sure PTO will be cost effective for the District but he definitely wants to look into it because if it is cost effective he thinks it's a better benefit and can be managed easier. After some discussion, Commissioner Werner **moved** to enter into a contract with Skye Mercer for Tier I at a cost of \$2,000. Commissioner Humphreys seconded. **Motion carried** unanimously. Ms. Mercer will provide a contract to the Clerk for the Board's approval. [12/18/19 Brd Mtg]

Road and Street Report

District Clerk Shirley Walson explained the report has been done as in previous years to show the legislators how funding is being used. Future projects are listed and HB312 funds are broken down to show how those particular funds were applied. Commissioner Werner **moved** to authorize signatures on the annual Road and Street Financial Report. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/18/19 Brd Mta]

Resolution 2019-08, Lancaster and Huetter Intersection Joint Safety Improvement Project Road Supervisor Kelly Brownsberger stated this is the resolution showing the District's participation in the application for the joint project with Lakes Highway District. Commissioner Werner **moved** to approve Resolution 2019-08 and authorize the Chairman to sign the resolution. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/18/19 Brd Mtg]

Credit Card Policy, Addendum I to Employees Policy

Ms. Walson explained the final addendum had a few updates to change it to a directive rather than an agreement format and removed one sentence after the review of attorney Susan Weeks. Commissioner Werner **moved** to approve Addendum I to our employment manual. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/18/19 Brd Mtg]

Rapids Bend Lane Right-of-Way Correction

Mr. Brownsberger reported the District received a public records request from a contractor to determine if there was public right-of-way across a parcel. In doing the research and after consulting with attorney Susan Weeks, it was discovered the District owns a 30-foot blanket easement. This came about from the 2007 recorded deed providing the right-of-way on an incorrect parcel which the county informed the owner they could not deed property that did not belong to them. The deed was rerecorded with a new legal description which covered the entire parcel, not just the southerly 30-feet that seemed to be the intent. A letter was prepared for the property owner in which the District offered to correct this situation but the Board preferred the Road Supervisor speak with him rather than to send a letter. To further complicate the matter, the contractor will ask for an approach permit. Attorney Susan Weeks reminded the Board that under the new access ordinance, this is a double access and the Board can make a condition of that access to with a second approach. Mr. Brownsberger will attempt to contact the owner. [12/18/19 Brd Mtg]

SH53 Pleasant View Intersection Cooperative Agreement

An agreement with ITD that when this interchange is built, the District will take ownership the frontage roads and the right-of-way associated with them which are Hollister Hills, the curve on Pleasant View along with the cul-de-sac on Hauser Lake Road at the end by the highway because the access will be blocked and it becomes a cul-de-sac. ITD will take ownership and maintain the overhead structures and off/on ramps. Commissioner Werner asked if there was now funding available but we have not heard of any yet. Commissioner Werner **moved** to authorize the Board to sign the cooperative agreement for Project Number A010(005), SH53 Pleasant View Intersection in Kootenai County, Key Number 10005. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/18/19 Brd Mtg]

SH41, E Prairie Avenue to Lancaster Rd Cooperative Agreement

Mr. Brownsberger stated this is the same type of agreement as the previous. It is supplying the District access into the Hayden Pit site off of Meyer Road. It will be to District standards with ownership and maintenance assumed by the District when built. Chairman Tondee asked about previous discussion where the road would be located. Mr. Brownsberger think ITD realized there was no other viable access that would be acceptable to the District except for this route. Commissioner Werner **moved** to approve Cooperative Agreement for Project Number A020(098), SH41, E Prairie Avenue to Lancaster Road, Key Number 20098. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/18/19 Brd Mtg]

LEGAL

Bob Haynes of Idaho Department of Water Resources has provided the proposed paperwork for water acquisition and water rights but asked that it not be filed until after the holidays. Anticipates

the hearing will be the first part of January. [12/18/19 Brd Mtg]

Magnuson Agreement – Ms. Weeks reports there has been no contact with the Magnusons' engineer. Commissioner Werner asked how long the Board wants to string this along as it has been a fifteen year process. Commissioner Humphreys concurs and feels the Board needs to proceed in a different direction. Ms. Weeks asked to put it on the next agenda. [12/18/19 Brd Mtg]

ROAD SUPERVISOR

Plow Truck Purchase – One bid was received after the advertisement from Freightliner Northwest in the amount of \$271,560. It meets all specifications with delivery time 316 days after they receive the order. Commissioner Werner **moved** approve the purchase of a new dump truck, sander wing, etc, from Freightliner Northwest \$271,560. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/18/19 Brd Mtg]

Crew Update - Sand and mag have been put down due to weather. [12/18/19 Brd Mtg]

ENGINEER

Prairie and Greensferry Partial Pay Estimate – Engineer Darius Ruen presented Pay Estimate #2 stating everything is done for the most part other than installation of the signal poles which should be delivered late January. Thoreco will then install and activate them some time in February. There were higher and lower costs than the estimate explaining savings on flagging and dust abatement since the intersection was closed; increases were spent on asphalt due to an irregular chip seal, the widening of outside edges, and a turnout of a driveway approach to give a better fit bringing the cost in at \$12,000 less than the engineer's estimate. Mr. Ruen recommended the Board pay \$464,986.79 for Pay Estimate #2. Commissioner Werner **moved** to pay Interstate Concrete and Asphalt \$464,986.79 for the Prairie and Greensferry Intersection project. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/18/19 Brd Mtg]

OFFICE

Set workshop for Director meeting – The Board requested to wait until such time Mr. Lenz is on Board and has had time to work with the current Road Supervisor answering questions as needed. [12/18/19 Brd Mtg]

Day at the Capitol – IAHD has again arranged a Day at the Capitol for a commissioner or staff member meets with our representatives. Commissioner Werner stated he would like to go this year since Chairman Tondee went last year. All were in agreement; arrangements will be made. [12/18/19 Brd Mtg]

January 1, 2020 Meeting Cancellation – Commissioner Werner **moved** to cancel the January 1, 2020 Board meeting. Commissioner Humphreys seconded. **Motion carried** unanimously. [12/18/19 Brd Mtg]
