Regular Meeting - May 6, 2020, 6:00 pm, E. 5629 Seltice Way

Chairman Tondee called the meeting to order at 6:00 P.M. Present were Chairman Todd Tondee and Commissioner Terry Werner; Director Michael Lenz, District Clerk Shirley Walson; and Administrative Assistant Korrei Kruger. Commissioner Lynn Humphreys, employee Paula Roukema, Engineers Darius Ruen and Laura Winter, guests Gordon Dobler, Richard Abbey, Drahosh Bulbuk, Dean Sutton, Brett Cummings, and JUB's Kevin Smith were present via telecommunication as allowed by Idaho Code 67-2342(5). Chairman Tondee led in the Pledge of Allegiance.

CONFLICTS; CHANGES TO THE AGENDA; APPROVAL OF AGENDA

Commissioners had no conflicts of interest. Commissioner Werner **moved** to add Invoice #6 for the Spokane Street River Bridge in the amount of \$12,823.58 payable to HDR Engineering. It's being added because Invoice 6 was missed in the pay line of 5 & 7. Commissioner Humphreys seconded. **Motion carried** unanimously. [5/6/2020 Brd Mtg]

CONSENT AGENDA

Items on the consent agenda are current vouchers, plat approval for Riverview Heights CDS, April 2020 Minutes, Invoices #6 and #7 for the Spokane Street River Bridge in the amount of \$12,823.58 and \$20,029.86 respectably, payable to HDR Engineering. Commissioner Werner **moved** to approve the Consent Agenda as presented. Commissioner Humphreys seconded. **Motion carried** unanimously. [5/6/2020 Brd Mtg]

PUBLIC COMMENTS

No guests requested to speak.

CURRENT BUSINESS

RFP, Greensferry Bridge Design

Ruen Yeager and Associates Engineer Laura Winter put together an RFP packet; it has been reviewed by Director Lenz but pointed out dates need to be entered to complete the RFP. Dates were discussed and settled; the RFP will be advertised May 14 and 21 with proposals due on or before June 1, 2:30 pm and award will be held June 17, 2020. Commissioner Werner **moved** to advertise the Greensferry Bridge Request for Proposal with the dates as discussed. Commissioner Humphreys seconded. **Motion carried** unanimously. *[5/6/2020 Brd Mtq]*

Wellington Heights Subdivision

Developer Richard Abbey provided a short history which included some confusion on road construction between the developer, Kootenai County and the Highway District. After much discussion including width of road, if a hammerhead is needed, ditches, specs being met, etc. Chairman Tondee referred to Mr. Abbey's drawing exhibit and stated the District is requiring the width to be 24-feet on the pink and yellow section and the blue sections are being treated as a private drive accessing four lots. As Kootenai County stopped providing minor plats for highway district reviews, the road was built at a lower standard than the District requires. Upon some discussion, the Director will meet the developer on site and a variance will then be discussed. [5/6/2020 Brd Mtg]

Hargrave Memorandum and Agreement

Project representative Gordon Dobler was present to discuss required road improvements for an unimproved portion of Hargrave road where it lays between Pleasant View and Corbin. Previous owners spoke with the District and an agreement was drafted but never signed. At that time the Board was already reviewing an unopened right-of-way policy and it has since been adopted, therefore what was decided with the previous owners is no longer valid. Commissioner Humphreys stated it has always been the District's policy that when developer's want access, they are required to develop the road to the District's standards with the costs being on the

developer. Chairman Tondee added the District would be happy to entertain a LID proposal. Commissioner Werner **moved** to deny the memorandum and agreement request to Hargrave before the Board. Commissioner Humphreys seconded. **Motion carried** unanimously. [5/6/2020 Brd Mtal

Seltice at Huetter, Transit Shelter Commitment

Ms. Walson explained the county wants confirmation the District will meet their match and Ms. Walson explained a letter had been sent months ago. The Board directed the District Clerk to notify Jody Bieze of Kootenai County Transportation the District still intends to meet the match as described in a letter dated June 3, 2019. A short explanation of the project was provided for the new director. [5/6/2020 Brd Mtg]

Riverview Drive Realignment at Dominican School & Richards Road

Engineer Darius Ruen stated this project is ready to go to bid and was ready to advertise it immediately. Material removal of this project is 17,000 cubic yards and there is no place for the District to put it with Chairman Tondee stating it would be on the contractor to dispose of it. At one time, the District was hoping to dispose one-half of it just up the road at a bad 'Y' intersection however this site is located in Washington who did not wish to support a project at that location. Director Lenz asked the Board to hold off since we don't know where the dirt will be disposed; Commissioner Humphreys then asked to investigate if there is any material the District can use. Mr. Ruen agreed that there could be some solids. Commissioner Werner **moved** to table this item until the next meeting to see if the material can be used by the District. Commissioner Humphreys seconded. **Motion carried** unanimously. [5/6/2020 Brd Mtg]

Post Falls Community Forest Parking Ordinance

At the previous meeting and after a parking complaint from a neighbor was received and the Board discussed potential problems to the edge of pavement, asking it be brought back to this meeting. Commissioner Werner stated we have a parking ordinance and is in favor of designating this area as a 'No Parking' area. Commissioner Humphreys felt that is such a low priority for law enforcement he did not feel signs would stop parking. Commissioner Werner **moved** to put signage next to the City's parking lot on Riverview Drive, signing it from there to Signal Point Drive and notify proper agencies. Commissioner Humphreys seconded. **Motion carried** unanimously. [5/6/2020 Brd Mtg]

CORRESPONDENCE

Church Road Letter – The District received a very complimentary letter from Power Solutions, Dale Routh, stated we are above average in the service we provide and his family has always arrived home safe, even when there has been over three feet of snow. The crew has been notified. *[5/6/2020 Brd Mtg]*

Water Right Hearing Rescheduled – Ms. Walson stated attorney Susan Weeks sent notice of the water right hearing to be held May 19, 2020 at 1:30 pm. [5/6/2020 Brd Mtg]

DIRECTOR

Economic Impact Early Reporting – Director Lenz spoke with Idaho Transportation Department's Damon Allen who stated gas tax was initially down 40% but has recovered to a negative 22% so they are planning a 30% hit to their FY21 budget. [5/6/2020 Brd Mtg]

Other Updates – The office staff will be fully staffed as of May 4; the head mechanic will be back the following week. May 18, under the Governor's Stage 2 order, will be allowed public in the office; masks, hand sanitizer and gloves are available with social distancing of six feet in effect. [5/6/2020 Brd Mtg]

Prairie and Pleasant View Intersection Update – This project is pushed back from June 6 to the week prior to Labor Day weekend; it is now scheduled July 6 with an end date of October 1. It will be out to bid in early June. [5/6/2020 Brd Mtg]

Pleasant View Road Grant - The City of Post Falls had asked for the District's support to obtain grant funding for Pleasant View Road. All parties had a meeting earlier in the week and the City has included the requested additional lane to the Prairie/Pleasant View roundabout. ENGINEER

MS4 Permit – Ruen Yeager's Laura Winter reports she is still waiting for the permit. The Director from the EPA needs to sign it and then we will receive it. [5/6/2020 Brd Mtg]

Prairie and Greensferry Signal – Engineer Darius Ruen reports the signal will be activated May 12 with the equipment director flying in that day as it gets lit up to ensure everything is working. Director Lenz assured Mr. Ruen the stop bars will be painted the day prior. 15/6/2020 Brd Mtal

OFFICE

Credit Card Payments – The hope was to have this going prior to the virus but that will be discussed at the upcoming office meeting. Commissioner Werner asked about the need but Ms. Walson stated the District receives numerous requests; Director Lenz asked for the number of permits issued which we can have for the next meeting. Chairman Tondee called the meeting to order at 6:00 P.M. CURRENT BUSINESS

Spokane River Bridge Update

Daniel Baker from HDR Engineering provided an update on this project. He reports since the January 15, 2020 update, they have now completed the final design; environmental approval is approved; and a meeting was held on April 29 with LHTAC, ITD and PFHD for comments and are now ready for the PS&E. The project is scheduled for FY2023 and he explained construction will be two parts, one for outer water work (May-August) and one in water (after September). Their design estimate is on track but they have pulled it off the shelf now as LHTAC froze funding on this project and will resume in spring of 2022 to prepare for the 2020 construction. Mr. Baker explained it was originally was a 2022 project, moved to 2023 but Director Lenz stated there was a possibility the project will be pushed to 2024 due to anticipated pandemic reduction in funding. Mr. Baker stated there is a possibility of stimulus funds becoming available due to the pandemic. [5/20/20 Brd Mtg]

Riverview Guardrail Installation Local Agreement

A standard State/Local Agreement for the Riverview Guardrail Project at a cost, not to exceed \$52,935. Commissioner Werner **moved** to approve the Local Professional Service Agreement for the Riverview Guardrail Project. Commissioner Humphreys seconded. **Motion carried** unanimously. [5/20/20 Brd Mtg]

MS4 Permit Review

Engineer Laura Winter would like to set a workshop to review the permit in the event there is anything the Board wants to appeal. Chairman Tondee felt there was needed discussion; the Board set the workshop June 3, 2020 at 4:00 pm. [5/20/20 Brd Mtg]

DIRECTOR

Riverview Heights Update – Director Lenz reported he, engineers Laura Winter and Darius Ruen, along with developer Richard Abbey met to review the road. He has met the 24-foot width until the top where he will build a cul-de-sac anyway so he will widen that portion of the roadway. There is still a lot of work to do to meet standards so they requested of Mr. Abbey to have his engineer map out the exact locations where they will be requesting variances. Chairman Tondee asked if they meet width, what are the variances for, is it slope? Director Lenz confirmed it is slope stating some are 13-16% and cannot see where they can smooth that out especially with the location of the creek. [5/20/20 Brd Mtg]

Skalan Creek Update – After a question from the hydraulic study was raised by the contractor, the engineer ran the settings again with acceptable results so the project will continue with a slip line into the existing culvert. The project is moving ahead slowly. [5/20/20 Brd Mtg]

Riverview at St. Dominic's Update - Director Lenz reported he, along with engineers Laura Winter and Darius Ruen discussed material use and/or disposal that will be generated from this project. Road Supervisor Dave Yerian does not think there is enough crushable material to make is worth the time of his crew. Another option is to stockpile an amount if the shed is moved, then when the road is shifted, move half of the fill back into the current alignment. This would leave approximately 8,000 remaining yards that could be moved to develop a new Stateline, Riverview intersection. Commissioner Humphreys asked if the owners of the property near the "Y" intersection had been contacted and if the Director was aware the "Y" intersection was located in Washington. The owners have not yet been contacted and the realignment he is speaking of is in Idaho, going on to explain there are further options that can be discussed at or need the "Y" intersection. Options and numbers are still being looked at. [5/20/20 Brd Mtg]

Office Update – Director Lenz plans to have the office fully open to the public by the June 3 Board meeting. [5/20/20 Brd Mtg]

OFFICE

District Clerk Shirley Walson reports the office has been very busy with Director Lenz interjecting the total number of minor subdivisions last year were five and we are currently at six so those will easily double; 23 approach permits as well as 32 use of right-of-way permits. [5/20/20 Brd Mtg]

COMMISSIONERS

Close Prairie and Beck, r/w will be needed on the south side of Beck to make the turn more gradual. Commissioner Humphreys stated there have been ownership changes in that location. Bill Crick is now the owner of the property in question. [5/20/20 Brd Mta]

Commissioner Humphreys stated he is concerned about possible lack of funding and would like to have a workshop on June 3 to visit if there are any projects we may want to adjust. He would like to visit with the other Board members. Commissioner Werner added he felt the District Clerk and Director were already keeping an eye on that and when they are ready, we should talk about it; he would also like to see what the July turnovers from Highway Users comes in. [5/20/20 Brd Mtg]

With no further business, Chairman Tondee adjourned the meeting at 6:37 PM.

Special Meeting - May 06, 2020, 4:30 pm, E. 5629 Seltice Way

Chairman Tondee called the meeting to order at 4:30 P.M. Present were Chairman Todd Tondee and Commissioner Terry Werner; Director Michael Lenz, District Clerk Shirley Walson; and Administrative Assistant Korrei Kruger. Commissioner Lynn Humphreys and Human Resource Consultant Skye Mercer were both in attendance via telecommunication as allowed by Idaho Code 67-2342(5).

PTO Projection Review & Discussion

As the Board has been in discussions regarding employee benefits, beginning with changing to Paid Time Off (PTO), District Clerk Shirley Walson prepared information for the Board showing four scenarios for sick benefits as well as how this would affect three random employees in employment benefits at retirement. Chairman Tondee stated the Board is trying to reduce the District's liability without increasing the expense and felt most these options increased the expense. Discussion continued within the Board members about options, ideas, liabilities of the District; and exchanges. Director Lenz asked about reducing some vacation with adding Veba as he is hearing from employees that would help them with the loss. The Board was polled with one wanting it left alone, one wanting a sick buy down now, reduce cap of sick hours, and no sick to be paid at separation; and one buy down now, cut the sick accrual in half, still payout sick at separation but with a maximum of 50%. Ms. Walson explained the sick bank to Chairman Tondee as the Board is entertaining keeping the sick bank or go to a CAT account. Ms. Mercer suggested the Board speak with Veba representative to see if he has suggestions regarding other ways to make up the loss of sick payout. She asked if the District wants incentivize employees for being here or incentivize them for when the leave. The Board asked the District Clerk to run some more numbers and meet with Ms. Mercer again on June 3. The Special Meeting was adjourned at 5:50 pm.
