POST FALLS HIGHWAY DISTRICT OCTOBER 2018 MINUTES

Regular Meeting – October 3, 2018, 6:00 pm, E. 5629 Seltice Way

Chairman Werner called the meeting to order at 6:00 P.M. Present were Commissioners Terry Werner, Todd Tondee, and Lynn Humphreys; Road Supervisor Kelly Brownsberger, District Clerk Shirley Walson; GIS Clerk Korrei Kruger; and District Engineer Darius Ruen. Guests were Angela Comstock of JUB; Laura Winter of Ruen Yeager, and Dirk Anderson.

CONFLICTS OR CHANGES TO THE AGENDA

No conflicts to the agenda were declared. No changes to the agenda were requested.

CONSENT AGENDA

The September 2018 Minutes was the single item on the consent agenda. Commissioner Humphreys **moved** to approve the minutes as presented. Commissioner Tondee seconded. **Motion carried** unanimously. [10/3/18 Brd Mtg]

PUBLIC COMMENTS

No one was present for public comments.

CURRENT BUSINESS

Carmel Heights, Dirk Anderson

The Carmel Heights subdivision is a four lot minor subdivision and has been required to pay \$3,500 per each additional lot. Developer Dirk Anderson is requesting the Board allow him to pay for a chip seal using District employees and equipment for approximately one-quarter mile. Road Supervisor Kelly Brownsberger stated this section of Carpenter Loop is scheduled for a chip seal in 2023 from Mead to Sandback Road, a distance of one-half mile. Mr. Anderson stated he is willing to do more than his one-quarter mile. After discussion, the Board asked the Road Supervisor to provide a cost. Commissioner Humphreys **moved** to that Mr. Anderson either pay \$3,500 fee for each additional lot in lieu of construction or pay for the chip seal. Commissioner Tondee seconded. **Motion carried** unanimously. [10/3/18 Brd Mtg]

Prairie and Pleasant View Intersection, Angie Comstock, JUB

Angie Comstock of JUB Engineers was available to answer the Board's questions arising from the previous meeting. All aspects were addressed as listed in the September 19 Board Meeting. Commissioner Humphreys added his concern of the trucking community and room for them to negotiate; Ms. Comstock stated with the 17-foot apron and mountable curbs, there will be a 37-foot negotiable driving area. Mr. Brownsberger recapped the federal funding for this project is to correct a safety issue and not for a large rebuild. [10/3/18 Brd Mtg]

Spokane Street Bridge Report

Rick Smith of Collins Engineers Inc. was contracted by Idaho Transportation Department to provide the inspection on the Spokane River Bridge. The final report has been submitted showing two items for concern. One is failing bearing pads and one is drainage onto the girders. Mr. Brownsberger spoke with LHTAC's Dan Coonce who is seeking an opinion from ITD as to including these fixes in the bridge project. [10/3/18 Brd Mtg]

Seltice Revitalization Project Payment #11; Pay Request #12

The City of Coeur d'Alene submitted payment #11 in the amount of \$2,777.60. Road Supervisor Brownsberger reported he believes the District's work is close to completion or is complete. Commissioner Tondee **moved** to pay Invoice #11, Pay Request #12, in the amount of \$2,777.60 for the Seltice Way Revitalization Project to the City of Coeur d'Alene. Commissioner Humphreys seconded. **Motion carried** unanimously. [10/3/18 Brd Mtg]

Riverview Guardrail Project, Appraisals & Acquisitions

Mr. Brownsberger received the final right-of-way plans and this project is ready to begin acquisitions. Although the District can do acquisitions in house due to the low costs proposed, Mr. Brownsberger stated the District reduces risk if done with the appraisal and acquisitions of an outside source. The Board agreed. Commissioner Tondee **moved** to allow the Road Supervisor to go forward with appraisals and acquisitions for the W. Riverview Guardrail Project. Commissioner Humphreys seconded. **Motion carried** unanimously. [10/3/18 Brd Mtg]

W Riverview (Skalan Creek) Payment #28

LHTAC submitted Welch Comer's progress report #28 in the amount of \$885.60 for the West Riverview (Skalan Creek) Project. Commissioner Humphreys **moved** to approve pay request #28 to Welch Comer in the amount of \$885.60. Commissioner Tondee seconded. **Motion carried** unanimously. [10/3/18 Brd Mtg]

CORRESPONDENCE

Barrett Road – Letters from Attorney Susan Weeks representing the District and Scott Poorman representing Jeff and Rae Jean Frank were presented for review by the Board. Access on Barrett Road was the subject as proposed by the City of Rathdrum to the Franks. So noted. [10/3/18 Brd Mtg]

ROAD SUPERVISOR

W. Riverview Approach, Variance Request – As a follow up from the last meeting, Mr. Brownsberger informed Nick Snyder of Kootenai County Waterways the District would prefer a common approach to the parcel on the northeast corner of W. Riverview and the Greensferry Boat Launch; both parcels have the same owner at this time. Once Mr. Snyder comes to an agreement, the owners will need to obtain an encroachment permit from the District. [10/3/18 Brd Mtg]

Flu Shots – Mr. Brownsberger informed the Board the flu shots will be scheduled for those who want them and they will be informed of the date and time. [10/3/18 Brd Mtg]

Road Closures – Union Pacific Railroad will be replacing the crossing at on Prairie Avenue between Idaho and Hayden on October 9, 10, and 11 from 6:00 am to 5:00 pm; the District will apply the patch work. BNSF will close McGuire Road at SH53 for crossing repairs on October 8, 9, and 10. [10/3/18 Brd Mtg]

Millview Lane Open House Response – As the open house prompted many concerns about the US95 and Fairmont so the Board directed staff to inquire with ITD and include the answer in the response. [10/3/18 Brd Mtg]

W. Riverview (Skalan Creek) Contracts – Mr. Brownsberger asked for all contracts to be corrected prior to signatures and correct the Lawrence's. [10/3/18 Brd Mtg]

Crew Update – Interviews have been completed for a position but not yet offered. The Assistant Road Supervisor and mechanic will go to Boise to inspect the new trucks. The crew has been working on Mellick Road on the unmaintained portion at the Department of Lands easement and winter changeover on the trucks has begun. [10/3/18 Brd Mtg]

ENGINEER

District Transportation Plan – Engineer Laura Winter reported the advisory committee has had time to submit final comments and she did not receive any and recommended to the Board it is ready to be adopted. The Board concurred it is ready and asked to place it on the next meeting agenda. [10/3/18 Brd Mtg]

Beck Road Open House – Mr. Ruen's staff would like the final approved budget amount prior to holding the open house, tentatively scheduled for October 25. Other research was needed prior

to bringing the proposed concept to the public. [10/3/18 Brd Mtg]

Updates – Engineer Darius Ruen reports the turn land on SH53 at Idaho Road is completed and the paving at Freddi and Winch will be completed later this month. Regarding the final payment for the Huetter Rehabilitation Project, he has not received word from the contractor that he is ready for final payment. Progress is being made on the Greensferry / Prairie Avenue signal design. Discussed was an update on the flood plain agreement with Kootenai County. [10/3/18 Brd Mtg]

OFFICE

2017/2018 Audit – District Clerk reported a single audit will be required because the District exceeded the \$750,000 federal funding limit. She spoke with CPA Scott Hoover who stated a new engagement letter will be required and the cost will increase. [10/3/18 Brd Mtg]

Ms. Walson asked the Board for comments on the projector that will be used for upcoming meetings. [10/3/18 Brd Mtg]

COMMISSIONERS

Commissioner Humphreys – Concerns were raised about the recent Cruisers special event stating no signage was on Seltice Way and the signage on Ante would be moved and/or fall down. Commissioner Humphreys asked them several time to replace the signage and it was not done; he added he had to escort two of his customers through the maze of this event due to poor signage care. Also, permanent markings were put down on Ante adding the event was done poorly compared to past years. [10/3/18 Brd Mtg]

Chairman Werner – A suggestion to review the District's updated web page was made by Chairman Werner who stated he had not realized it was being done and was pleasantly surprised by the clean design citing new employee Korrei Kruger has done a very nice job. He also stated the ribbon cutting ceremony at the Prairie and Chase roundabout went very well earlier in the day. Representatives from LHTAC, Ruen Yeager, T. LaRiviere, and Greenacres Irrigation Water District were present. He encouraged those present to contact the local state legislature representatives to again approve this funding. [10/3/18 Brd Mtg]

This year, there is \$.61 per ton increase from the previous year, or \$0.3 per gallon. Commissioner Humphreys **moved** to accept the bid as presented on the state contract at \$164.47 per ton. Road Map Acceptance

Engineer Darius Ruen reported several reviews have been completed on the 2018 official road map. Commissioner Humphreys **moved** to accept the 2018 Official Road Map as prepared by our District engineer. Chairman Werner seconded. **Motion carried** by majority vote. [10/17/18 Brd Mtg]

Beck Rd Progress Report 9

Commissioner Humphreys **moved** to approve Pay Request #9 in the amount of \$11,331.32 for the Beck Road, Seltice Way to Prairie Avenue project. Chairman Werner seconded. **Motion carried** by majority vote. [10/17/18 Brd Mtg]

Pleasant View & Prairie Progress Report 2

Commissioner Humphreys **moved** to approve Pay Request #2 in the amount of \$11,169.84 for the Intersection of Pleasant View Road and Prairie Avenue project. Chairman Werner seconded. **Motion carried** by majority vote. [10/17/18 Brd Mtg]

Gallagher Benefits, Client Coverage Acknowledgement

Chairman Werner reported this is the typical acknowledgement to continue using Gallagher Benefit Services for our insurance broker. Commissioner Humphreys **moved** to accept the Acknowledgment statement for FY 18/19 naming Gallagher Benefits as the District's representative. Chairman Werner seconded. **Motion carried** by majority vote. [10/17/18 Brd Mtg]

ICRMP Trustee Nomination

Beck Road – Supplemental Agreement

Terracon Consultants will explore alternative flexible pavement sections to potentially reduce construction costs. Commissioner Humphreys moved to accept the supplemental agreement with Terracon in the amount of \$5,000. Chairman Werner seconded. **Motion carried** by majority vote. [10/17/18 Brd Mtg]

Children Pedestrian Safety Program

Road Supervisor Kelly Brownsberger received a letter from Eric Olson, P.E. to volunteer his time to help with an application for the Child Pedestrian Safety grant application if the District will sponsor it. The affected areas are Aspen Way/Park Dr/Evergreen Dr from Cedar Street to Ross Point Road and Woodland Drive from Cedar Street to Evergreen Drive. Dimensions were discussed. Commissioner Humphreys **moved** to pursue the Child Pedestrian Safety Grant and put together an application with Olson Engineering. Chairman Werner seconded. **Motion carried** by majority vote. [10/17/18 Brd Mtg]

CORRESPONDENCE

Union Pacific Spur Removal – The Road Supervisor supplied the Board with a support letter from the District to Union Pacific Railroad. This letter was at the request of Idaho Transportation Department to help move along the purchase by several entities. [10/17/18 Brd Mtg]

ROAD SUPERVISOR

Spokane Street Bridge – Mr. Brownsberger reports he spoke with LHTAC's Dan Coonce regarding the needed bearing replacements being added to the upcoming project to resurface the bridge. Mr. Coonce spoke with ITD and all believe it to be possible. Heather Carol of HDR Engineering who is designing the project will include it in the plans. A definitive answer will come when it is designed. [10/17/18 Brd Mtg]

Prairie and Pleasant View Open House Plans – Mr. Brownsberger has reviewed them with JUB Engineers. LHTAC's Susan Kiebert will be present as the hearing officer. Chairman Werner stated his desire to have the second lane built now even if the District has to pay for it. Mr. Brownsberger will meet with BNSF and ITD regarding the roundabout. Angela Comstock from JUB will be present. [10/17/18 Brd Mtg]

W Riverview (Skalan Creek) – Mr. Brownsberger and Mr. Ruen met with several property owners the previous night to answer concerns they had about land acquisitions. Mr. Brownsberger discussed the situation with project designer, Matt Gillis of Welch Engineering; right-of-way agent Ron Harvey is aware of the situations. LHTAC's Dan Coonce is concerned that if not completed soon, next year's construction schedule cannot be met. [10/17/18 Brd Mtg]

Water Line Extension – The City of Coeur d'Alene has inquired about extending the water line from I90 to the well site along Huetter Road. The District has a no-dig five year moratorium after a road has been resurfaced. As Huetter was just done and if the City persists, it will be costly. [10/17/18 Brd Mtg]

Huetter Right-of-Way Acquisition – For the Armstrong acquisitions, Roy Armstrong contacted the District stating the vesting needs to be changed. Ron Harvey who is doing the acquisition was notified. [10/17/18 Brd Mtg]

Mellick Road – Mr. Brownsberger notified the crew completed work of a portion of road in the newly acquired easement on Department of Lands section of land. [10/17/18 Brd Mtg]

Millview Lane Open House – The draft comments have been compiled and were made available for the Board's review. [10/17/18 Brd Mtq]

Stop Sign Beacon Upgrades – Crashes are still happening at the intersections where the flashing lights were installed on the Prairie. Mr. Brownsberger spoke with Trafficom who will do an upgrade using the type of flashing beacon that activate on the stop ahead signs. [10/17/18 Brd Mtg]

Crew Update – The crew has been working on Nelson Loop, striping, and working on Pinevilla drywells. A claim was filed last week for paint on a vehicle. Interviews have been conducted and will fill the opening through Integrated Personnel; Darryl Stevens begins the following week. [10/17/18 Brd Mtg]

ENGINEER

Prairie/Greensferry Intersection – Ruen Yeager has been in the process of designing for the signal at this intersection. Mr. Ruen discussed turn lane and transition lengths, projected life of the improvement, possible acquisition, and challenges. A CRABS (Cement Recycled Asphalt Base Stabilization) from the intersection, east to SH41, was also discussed to complete the project and match it up with the SH41 project. [10/17/18 Brd Mtg]

Chairman Werner asked about cold mix being dumped at the corner of the Lancaster and Greensferry intersection. Mr. Brownsberger stated the crew did that to help with the radius and although it stands out right now, it has helped that corner. [10/17/18 Brd Mtg]

Commissioner Humphreys asked that Ante Road can be looked at behind Cruisers. Ecology blocks have been placed in such a manner that he deems it to be a hazard. [10/17/18 Brd Mtg]

Chairman Werner asked if Poe Asphalt has been in contact with the engineer regarding final payment on the Huetter Road project. Mr. Ruen said he will contact them and have an answer by the next meeting. [10/17/18 Brd Mtg]
